Construction of New Soil Testing Laboratories Building works including Electrification and Water arrangement works as per requirement complete. Details of works and locations may be seen in the Office of M. P. State Agricultural Marketing Board, Bhopal.

Envelope A:

Bidder must submit (Online upload and Hard Copy) self attested copy of:

1. Valid Registration for civil works, Registered with the office of ENC, MP PWD, Bhopal (as per NIT).
2. Valid PAN Number,
3. Valid GST registration of MP State.
4. Consent of Valid "A" Class electric license of any person or employee issued by the Chief Electrical Advisor to the State Government of MP for executing the electrical works(if any) and "A" Class Electrical License Copy.
5. The entire contractors must submitted an affidavit as per tender form Annexure - "B"
6. Valid EPF Registration.
7. Valid ESI Registration (*Work Compensation Policy will not be allowed*).
8. Firm Establishment Registration.

Envelope B:

Online bidder must have submitted (Online upload and Hard Copy):

1. EMD in the form of FDR / TDR of any Schedule of Commercial Bank in favour of the **Accounts Officer, MP State Agricultural Marketing Board Bhopal.**

[No other form of EMD (Demand Draft, Bank Guarantee etc.) will be allowed]

Envelope C:

The Envelope No. A & B shall be sealed separately and placed in a third Envelope which also shall be sealed and duly super scribed with the name of the work and Name & address of tenderer.

The last date to receive the hard copy of all above documents is **19.12.2017 up to 17:30Hrs** through speed post / Registered Post only.

3. TERMS & CONDITIONS:

1. The tenderers are required to quote only one rate of percentage above/ below/at par on the following Schedule of Rates issued by the Engineer in Chief M.P. PWD including the amendments approved by the Managing Director, MPSAMB upto the date of issue of Notice Inviting Tenders.
 - a. Schedule of Rates of building works, M.P. P.W.D. Building S.O.R. with effect from 01.08.2014 Amended upto issue date of NIT.
 - b. Schedule of Rates of electrical works M.P. P.W.D. Electric work S.O.R. with effect from 01/08/2014 (Amended upto issue date of NIT.)

As per the MP PWD Bhopal, General Notes dt 24.08.2017 and MPSAMB Bhopal office order no.2253 dt 30.08.2017, the rates of all the items in above mentioned (a & b) SOR with all amendment till 24.08.2017 have been reduced by 10% and the same will be valid on this tender.
 - c. Schedule of Rates of M.P.P.H.E Department with effect from 01/06/2016 Amended upto issue date of NIT.
2. The working site as mentioned in NIT is subject to the permission of concerned District Collector. In case of change of site due to any reason, the bidder shall have to work at changed site.
3. THE BIDDERS ARE REQUIRED TO OFFER THEIR BIDS EXCLUSICE OF APPLICABLE GST. THE GST SHALL BE PAID BY THE GOVERNMENT TO THE CONTRATOR SEPERATELY. But inclusive of all other taxes and duties (except GST).
4. In case of implementation of any new / amendment of tax rules (up to the date of NIT) by government, the same will be valid on the rate quoted by contractor / deemed to inclusive of the same. In this regard, the decision of Mandi Board will be final and binding.
5. TDS, LWF, SD etc. will be deducted from RA / Final Bills as per norms and rules.
6. The quantities mentioned in "Bill of Quantities" are estimated quantities. However the payment shall be made as per actual quantities measured at site, after completion of work. All other conditions regarding submission of working drawings etc will be as per tender form.
7. Tender documents may be purchased online on payment through cash card, ATM Debit Card & Internet Banking Account.



8. All other terms and conditions will be as per tender form. In case of any discrepancy / dispute, the decision of Managing Director, MP State Agricultural Marketing Board will be final and binding on both the parties.
